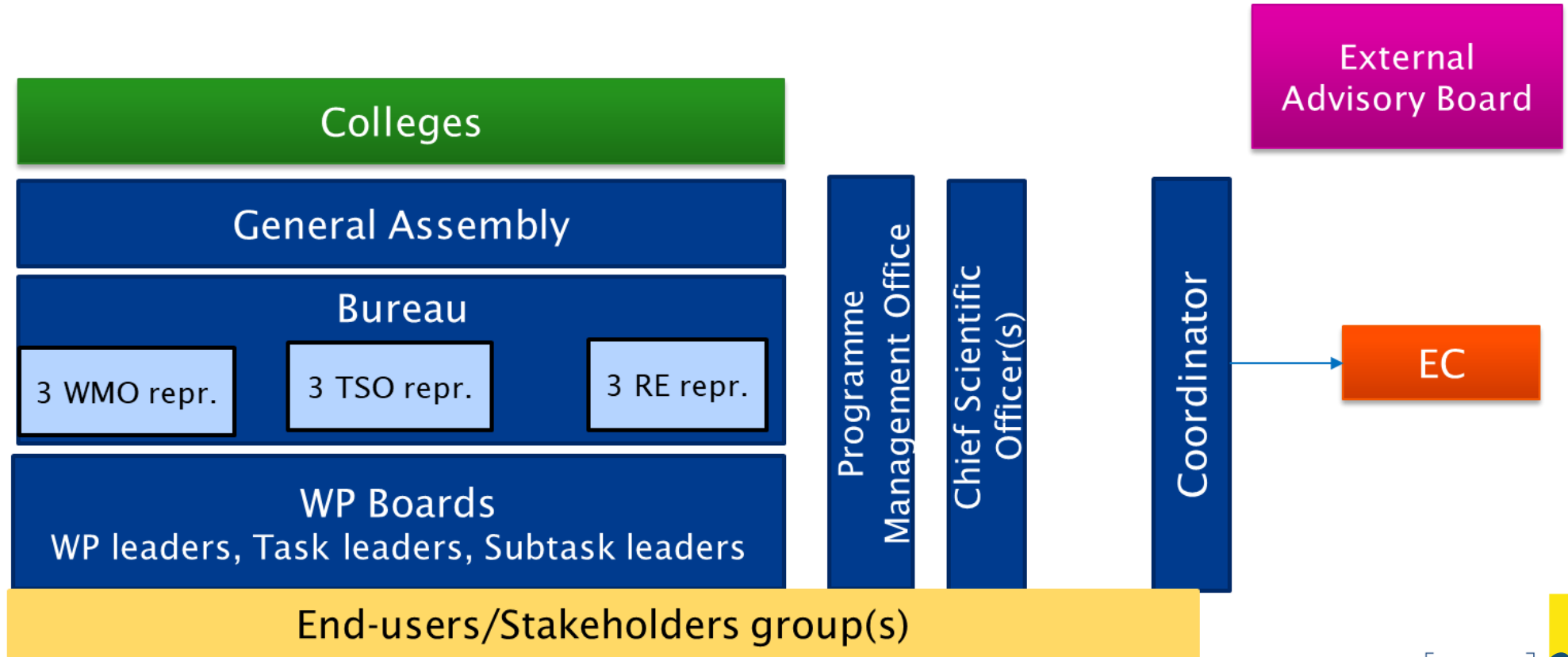

MISSION

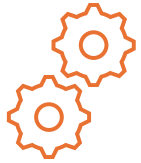
- Day-to-day management

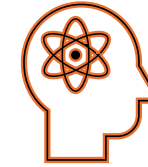

- Contribute to dissemination of WP activities and results



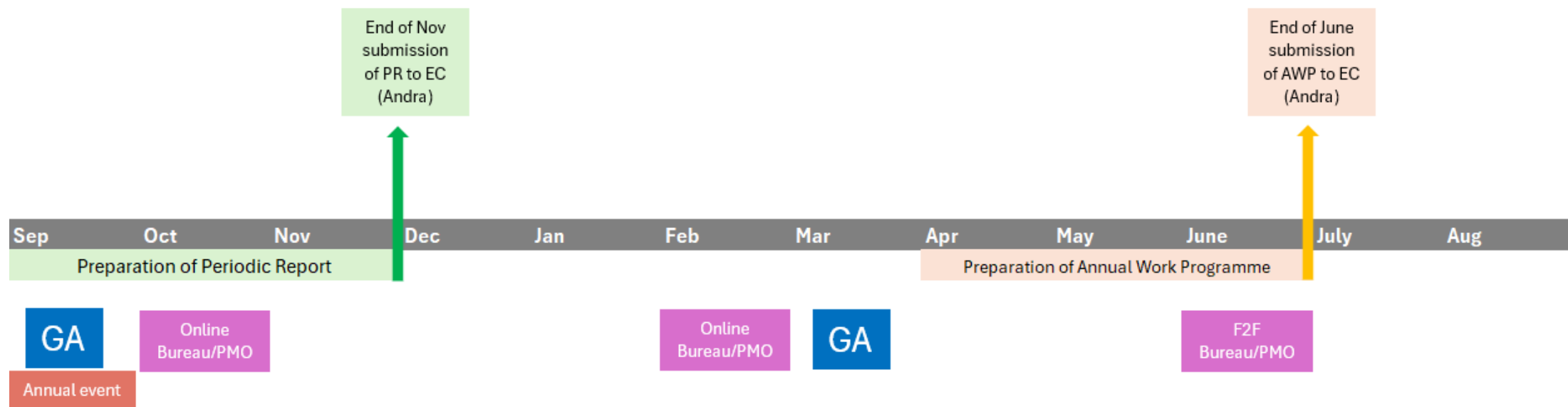
END-USERS GROUP
