CONTEXT: EURAD-2 FLEXIBILITY MECHANISM

EURAD-2's ambition is to be **as needs-driven as possible**; therefore, the programme will again be **deployed in a two wave format** to ensure the possibility of **integrating any new emerging from the community**. Therefore, only part of the budget is allocated at the start of the programme. The remaining is provisioned under the Coordinator's budget.

It is anticipated that the **second wave** of work packages (WPs) will be **defined in 2025-2026 depending on available Euratom funding**, to allow a **duration of 3 years** for those additional future work packages.

Proposals for new Research, Development and Demonstration (RD&D) and Strategic Studies (StSt) WPs will emerge as EURAD-2 progresses. These will be considered in an **open and transparent process** guided through the EURAD-2 governance structure. After this selection process, the WPs will be reviewed and **approved by the General Assembly**.



CONTEXT: 2 WAVES OF RD&D & STST ACTIVITIES

EURAD-2 Programme was built considering:

- A 1st EC grant of 20MEUR at the beginning of EURAD-2 + a 2nd grant (top-up) of at least 20MEUR at year 3.
- 2 Waves of R&D and StSt activities.

CONTEXT: NEED OF A SELECTION PROCESS

- Development of a selection process which is:
 - Fair for the different categories of EURAD actors;
 - Steered by the EURAD Vision, Roadmap and SRA;
 - Shared and approved by the EURAD community;
 - Aligned with the context for the 2nd wave (possible number of WPs...).
- This process was developed by the Bureau, introduced at GA2 and published on 3/06/2025.




SELECTION PROCESS: BASIC PRINCIPLES


- 3-step development process for new WPs activities
 - Template #1 (3/09/2025, proposals of topics for new WPs non-consolidated between colleges)
 - Template #2 (10/12/2025, WP proposals consolidated between colleges)
 - Template #3 (30/04/2026, final WP proposals consolidated between the colleges)
- Current StSt are allowed to propose R&D WPs connected to their scope of activities <u>directly</u> in a template #2 (no template #1 needed).
- The proposal of all other 2nd wave activities have to go via a template #1. Proposal meeting a joint interest from the Colleges will then be further described in a template #2.
- Selection of the template #2 WP proposals allowed to move to template #3 will notably depend on the top-up budget. So we need "enough" templates #2 to manage the uncertainty about the top-up budget (20MEUR, or 30, or...?).

SELECTION PROCESS: 3RD OF SEPTEMBER TO 10TH OF OCTOBER 2025

To do by the Colleges:

- Colleges organise themselves to identify the topics for new activities they want to include in template #1.
- Colleges fill in template #1 and submit them to the Bureau.
- Maximum 4 R&D templates #1 and 2 StSt templates #1 per College.

Important remarks:

- 1st wave StSt WPs wishing to propose 2nd wave new StSt (e.g. in an additional task in their WPs) or RD&D (not connected with their scope) activities shall provide a template #1 via a College.
- Similarly, 1st wave RD&D WPs wishing to propose 2nd wave new StSt or RD&D activities (e.g. in an additional task in their WPs) shall provide a template #1 via a College.
- Eligibility criteria:
 - Be consistent with EURAD Vision, SRA and Roadmap;
 - Be linked to EURAD SRA topics and associated drivers;
 - Avoid duplication of existing international activities or repetition of what has been done in the past (at national or European levels);
 - Do not cover topics that are currently being addressed by other ongoing EC projects (both within and outside of EURAD-2);
 - Respect the selection process Terms of References.

SELECTION PROCESS: 3RD OF SEPTEMBER TO 10TH OF OCTOBER 2025

To do by the Bureau and PMO:

- Bureau will communicate on 8th of September the list of templates #1 received from the Colleges ("long list of topic proposals").
- PMO will evaluate the eligibility of the proposals by the 30th of September.
- The Bureau, in close liaison with the Colleges and contact persons of the template #1, will consolidate the received eligible topics in possible WPs.
- This list of possible WPs, as well as the identification of WP coordination teams (1 representative by College) for each of the WPs, have to be available on the 10th of October 2025.

Important remarks:

- For defining the consolidated list of eligible WP proposals, the initial College topic proposals will not be modified, but some proposals could be merged together for instance if they cover similar topics.
- The Bureau will not "force" the merge of proposals but will play the role of a facilitator and let the Colleges (in connection with the organisations supporting the proposals) decide if such a merge is relevant from scientific point of view.



SELECTION PROCESS: 10TH OF OCTOBER 2025 TO 10TH OF DECEMBER 2025

To do by the Colleges & WPCT:

- Each WPCT is responsible to evaluate if a joint WP proposal can be developed.
- The Colleges need to support / liaise with the WPCT.
- If the Colleges conclude that a WP proposal does not meet enough joint interest, the WP proposal will be dropped.
- For the proposals meeting a joint interest from the 3 Colleges, a template #2 is expected on 10th of December 2025.

Important remarks:

- Exchange meetings will be organised online end of October to promote discussions between Colleges (dates will be announced soon, registration needed).
- A physical meeting will be organised on 26/11/2025 afternoon in Prague (aside of the IGD-TP Exchange Forum). Registration needed: https://igdtp.eu/igd-tp-exchange-forum-2025-registration-form/



SELECTION PROCESS: CURRENT STST TO MAKE PROPOSALS OF R&D WPS BY 10/12/2025

To do by 1st wave StSt WPs:

 The 1st wave StSt WPs are invited to directly propose 2nd wave RD&D WPs in a template #2 (see Appendix B) by 10 December 2025. This mechanism allows the StSt WP to progress in their work programme and to identify needs of new activities until Month 14, before submitting 2nd wave WP proposals.


Important remarks:

- In this mechanism filling and submitting a template #1 is not required.
- 1st wave StSt WPs wishing to propose 2nd wave new StSt (e.g. in an additional task in their WPs) or RD&D (not connected with their scope) activities shall provide a template #1 via the Colleges.
- The StSt WP Boards must liaise with their corresponding WP participants and the Colleges before proposing a template #2, to have consensus on the RD&D WP scope and need.
- 1st wave StSt will also be consulted in the period October December 2025 to detect and, if found appropriate, integrate 1st wave StSt recommendations in the WP proposals coming from proposals formulated through the Colleges template #1.



SELECTION PROCESS: JANUARY 2026

- According to EC planning, we should know how-much top-up budget is available.
- The templates #2 will be ranked by the Bureau, in close liaison with the Colleges.
- 3 main criteria will be followed:
 - High common interest from the three Colleges toward a proposal that plugs a gap identified in the SRA relative to fulfilment of the EURAD Vision,
 - Joint drivers expressed in the SRA for the topics are covered,
 - To what extent does the proposal contribute to EURAD collaborative RD&D / Strategic Studies objectives (as described in EURAD founding documents).
- Considering the top-up budget and the abovementioned ranking, a certain number of WP proposals will be allowed to moved towards template #3.
- the Bureau estimates a maximum EC contribution of 1.5M€ (3M€ of eligible costs) for a 3-year 2nd wave RD&D WP and 0.75M€ (0.75M€ of eligible costs) for a 2-year 2nd wave StSt WP (considering that a 2nd wave StSt WP would only last 2 years to allow capitalising its results in a possible proposal for a third EURAD implementation phase).
- If the top-up = 30MEUR, we anticipate ≈ 7 R&D WPs and 3 StSt.


SELECTION PROCESS: FEBRUARY TO JUNE 2026

- Template #3 development: until the 30th of April 2026.
- Expected level of detail = what is needed to answer to the EC call for the second grant (top-up).
- Approval of the 2nd wave new WPs by the EURAD-2 GA in June 2026.

SELECTION PROCESS: JUNE 2026 TO END OF AUGUST 2026

- PMO prepares the 2nd wave proposal to be submitted to the EC. It will be submitted by the end of August 2026.
- The WP Boards will further develop their WP descriptions, to be ready for a kick-off beginning of October 2026.



Guidelines:

The proposal should not exceed two pages. The deadlines of submission are defined by each College. The Colleges will submit the proposals to the Bureau by **September 3rd 2025** at the latest.

To facilitate the process, the subject line of email should state: "[EURAD-2 2nd wave topics proposal]".

Proposals that are not submitted via the Colleges, cannot be considered for EURAD-2 2nd wave.

Boundary conditions:

- EURAD-2 programme is a co-funded partnership. This implies that every organisation intending to participate, agrees to provide co-funding to the action and share every data or document publicly.
- EURAD-2 work packages will have to be inclusive, they should be of benefit for different Member States, regardless of their stages of advancement. To be considered eligible, they should be supported by at least 5 different Member States.
- a maximum total budget per work package proposal (EC distribution + co funding) of is **recommended**:
 - 3 million € for a R&D work package
 - 0.75 million € for a Strategic Study work package
- The content of the proposal should not disclose any sensitive or confidential information (patent pending, contract not signed, ...)

Please be prepared that you may be asked to pitch this proposal at the EURAD-2 2nd wave webinar, to be held in October 2025, and/or at the EURAD-2 2nd wave WP discussion, to be held in Prague on November 26th.

FREQUENTLY ASKED QUESTIONS

Two received questions:

Q1: In the document presenting the selection process for the second wave activities of EURAD-2, I read, at the bottom of p8: "contact point from the College making the proposal. The contact point cannot be a member of the PMO or the Bureau or a current WP Leader (WPL);". If a new activity is proposed to be included in an existing WP, can the WPL be the contact point?

The concerned WPL should be kept informed of the development of such proposals. However, it should be avoided that the WPL becomes the contact point of such a proposal (this could be accepted only as a short-term solution, waiting for the identification of another contact point).

Q2: Is there any action required from the WP Leaders to ensure the continuation of already running WPs, i.e. for the remaining 3 years of EURAD-2. Essentially, do we need to take action (e.g. apply anew) in order to get the rest of the resources we initially requested for the whole 5 years' duration?

The submission of a topic is only applicable in case the WP wants to add activities to the existing WP. The budget for the remaining 3 years of activities already described in the programme do not need to be submitted.
